New Research Infrastructure suggested

In August, the final report on the future of the Swedish research infrastructure was published. One of the most important proposals was to create a common digital infrastructure for the exchange of information that extends across the entire public administration.

To implement this, the inquiry proposes that digital infrastructures that support research be brought together in a new authority - the Authority for Digital Infrastructure. The activities and organizations currently affected by the proposal include the Swedish National Data Service (SND); The register assignment; National Archives Database (NAD); The organization of Swedish National Infrastructure for Computing (SNIC); The Mona system at Statistics Sweden (SCB), and SUNET's activities at the Swedish Research Council.

Reinforced DAU reviews guidelines

The 23rd of September the BTH DAU met with the researcher reference group to discuss details in the suggested Guidelines for Managing Research Data.

There is now agreement of the wording of the document but also of having the guidelines scrutinized by a "third party lawyer" before the document goes to the vice-chancellor just to have an extra check that there are no wordings that would restrict researchers to work with company data.
